Sub: Telangana State – Elections held for State Assembly during November 2023 – Uncontrolled expenditure by Government to conduct elections – Request to audit the expenditure by A.G. – Reg.

-: S :-

Election Commission of India notified the expenditure limit of Rs. 40 lakhs per candidate contesting elections to legislative Assembly elections held in November 2023. Special expenditure observers were appointed to each constituency to watch and audit of expenditure of the candidates. The Commission has fixed the rates for food items etc. which the candidates have to follows while calculating expenditure.

As per sec. 78 of Representation of People Act, "Every contesting candidate shall within 30 days from the date of election lodge with the district election officer on account of his election expenses". Accordingly, the candidates have filed their accounts which were put on website of Election Commission and are in public domain. Forum for Good Governance analyzed the expenditure statements of candidates and found that the total amount spent by them for elections is anything from Rs.20 lakhs to 35 lakhs only. Officially no candidate has spent more than Rs.40 lakhs the sealing fixed by Commission, though the actual position is something different.

Forum for Good Governance received some complaints that uncontrolled expenditure is incurred by officials entrusted with election work. To know the facts, we have filed R.T.I. applications with all the district collectors to furnish the constituency wise expenses incurred for conduct of Assembly elections held in November 2023. Many of the collectors did not respond to our applications. Few collectors forwarded our request to

R.D.O.s who inturn sent it to M.R.O.s So far, we have not received any information from M.R.O.s (Ann I). Finally, we requested the Prl. Secretary Finance to provide information regarding budget release for conduct of Assembly elections. As per Prl. Secretary Finance an amount of Rs. 701.11 crores is the budget release to conduct elections to 119 Assembly seats in Telangana which work out to 5.9 crores per constituency (Ann II).

While the contesting candidates spent on an average of Rs. 30 lakhs per Assembly the Election Commission spent Rs. 5.9 crores on each Assembly constituency to conduct elections.

As the election expenditure is not audited we have a reason to believe that wasteful expenditure is being incurred by officials conducting elections. The Chief Electoral Officer Telangana is requested to kindly get the election accounts audited and put in public domain as is being done in case of contesting candidates.



₹701cr spent on Nov 2023 assembly polls: RTI reply

Hyderabad: An amount of ₹701 crore was released from the budget to conduct elections to 119 assembly seats in Nov 2023, which works out to ₹5.9cr per constituency, according to an RTI reply from Telangana principal secretary of finance department.

Forum for Good Governance, which filed the RTI application, said that it had recieved several complaints on wasteful expenditure for the conduct of elections and demanded an audit.

"While the contesting candidates spent ₹30 lakh, on an average, the Election Commission spent ₹5.9cr on each constituency to conduct the elections. As the election expenditure is not audited, we have a reason to believe that wasteful expenditure is being incurred by officials while conducting the elections," said Padmanabha Reddy, FGG secretary.

FGG demanded that Telangana chief electoral officer get the election accounts audited and place it in public

domain, as being done in case of contesting candidates.

"EC had notified the expenditure limit at ₹40 lakh per candidate contesting the assembly elections. Special expenditure observers were appointed to each constituency to watch and do an audit of expenditure of the candidates. The EC even fixed the rates for food items, etc., which the candidates had to mention while calculating the poll expenditure," Reddy said.

The candidates filed their accounts which were posted on EC website. "We analysed the expenditure statements of candidates and found that the total amount spent by them for elections was anywhere between ₹20 lakh and ₹35 lakh only. Officially, no candidate has spent more than ₹40 lakh as per the sealing fixed by tdhe commission though the actual spending would be different." Reddy said.

The FGG secretary said after receiving complaints about uncontrolled expenditure incurred by officials entrusted with election work, they filed the RTI applications with all the district collectors.

"Many collectors did not respond to our applications. Some collectors forwarded our request to RDOs who, in turn, sent it to tahsildars. So far, we have not received any information from tahsildars. Finally, we requested the finance secretary to provide information regarding the budget release for the conduct of the assembly elections," Reddy added.
